



## ROSETOWN PHOTO CONTEST

The Town of Rosetown will be launching a new website and we need your help to find creative ways to showcase Rosetown at its finest. We are looking for photos that capture Rosetown's spaces, places, events, activities and community spirit – that's where you come in!

To enter the **Rosetown Photo Contest**, simply send us your photographs that capture Rosetown in all its glory. There is *no limit to the number of photos you can submit*, nor how many prizes you are eligible to win.

The **deadline** to submit your photos is **Friday, October 13, 2017**, after which time the winners will be selected by a panel of judges and announced online and in the community. Photos will be judged on originality, style, composition, photographic quality and appropriateness of theme (how well they capture the spirit of Rosetown).

**First Place Winner:** \$125 in Chamber Bucks

**Second Place Winner:** \$75 in Chamber Bucks

**Third Place Winner:** \$25 in Chamber Bucks

All photo submissions may be used on the Town of Rosetown website, [www.rosetown.ca](http://www.rosetown.ca), or in printed material.

- Resolution (300 DPI)
- Colour (b/w or colour)
- Format (JPEG, TIFF, PSD, PNG)

**\*Note:** Photographs containing people must be nondescript (ex. at a distance or from behind) and/or of 4 or more people in public space. Photos of individual people as the principal subject will only be considered with written permission from the subject, or their parent/guardian, in the case of minors. If applicable, please note this on the Photo Contest Entry Form.

## **Rosetown Photo Contest – Terms and Conditions**

The Rosetown Photo Contest is a contest run by The Town of Rosetown. All questions with respect to the contest Terms and Conditions should be directed to the Town Office by phone (306-882-2214), email ([businessrosetown@sasktel.net](mailto:businessrosetown@sasktel.net)) or in person at the office (417 Main Street, Rosetown, Saskatchewan, S0L 2V0).

All photos submitted to the Rosetown Photo Contest (hereby known as “Contest”) become licensed to the Town of Rosetown (hereby known as “Authorized Party”). By submitting a photo entry to the Contest, and in consideration of the opportunity to win prize(s), you agree to give the Authorized Party full print and digital publication rights for all submitted photos. By entering the Contest, all entrants grant an irrevocable perpetual, nonexclusive license to the Authorized Party, to reproduce, publish, display, distribute and create derivative works of the entries in connection with the contest and promotion of the contest, and for purposes or promotion, advertising, and trade of publications owned, operated, controlled, published or distributed by the Authorized Party. The Authorized Party will not be required to pay any additional consideration or seek any additional approval in connection with such use. You represent and warrant that the photograph(s) you submit is an original work by you, that you own or control 100% of the rights in and to your photograph(s) and the rights granted to the Authorized Party in this license, and such rights are and shall be free and clear of any and all claims, rights and obligations; and that you have the right to grant to the Authorized Party the rights granted to us in this license, you do not require the consent of any third party and that there is no contract with any third party that could in any way interfere with the Authorized Party rights under this license or require any payment to be made to anyone by the Authorized Party.

### **Judging**

Winning photographers will be chosen by a selection committee comprised of selected representatives from the Authorized Party. Photographs will be judged on originality, style, composition, photographic quality and appropriateness of theme (photos that capture Rosetown’s spaces, places, events, activities and community spirit). Identifying information will be removed/excluded from photos during the judging process to ensure impartiality.

### **Prizes**

There will be one grand prize consisting of \$125 in Chamber Bucks for the selected first place winner. Second and third place winners will be awarded \$75 and \$25 in Chamber Bucks, respectively. Additional prizes may be awarded to honorable mentions as determined by the selection committee. In addition to awarded prize(s), the Authorized Party will publish winning photos on the Town of Rosetown website ([www.rosetown.ca](http://www.rosetown.ca)), provided that the image meets the aesthetic, editorial and moral standards of the website, as determined by the Authorized Party. Should a winning photo be deemed inappropriate for website or a future publication, the Authorized Party is not obligated to publish the photo, but other prize(s) will still be awarded. The contest deadline is stated on the contest website: [www.rosetown.ca](http://www.rosetown.ca)

In the event that a selected entrant does not comply with these Contest Terms and Conditions, or cannot be contacted within two weeks of his/her selection, an alternative entrant will be selected from

the remaining entries. The prizes must be accepted as awarded, are non-transferable and cannot be redeemed for cash. All federal, provincial and municipal taxes are the sole responsibility of the winner.

**Eligibility**

This Contest is open to all residents in the Town of Rosetown and surrounding areas.

**How to Enter**

Individuals who meet eligibility requirements *may enter multiple photographs*, provided each image is an original photo taken by the entrant. The photographer must hold copyright to all photos submitted to the contest. Eligible persons can email their photographs in to [businessrosetown@sasktel.net](mailto:businessrosetown@sasktel.net), preferably in one email.

**Liability**

The Authorized Party is not responsible for any entries which are incomplete, lost, stolen, destroyed, delayed, or not transmitted due to technical failure, whatever the cause. The Authorized Party shall not be liable for any direct, indirect, incidental, special, consequential, or exemplary damages, including but not limited to, damages for loss of profit, goodwill, use, data or other intangible losses (even if the Authorized Party has been advised of the possibility of such damages), resulting from: (i) the participation, uploading or downloading of any materials related to this Contest; (ii) unauthorized access to or alteration of your transmissions or data; or (iii) any other matters relating to the Contest. The Authorized party reserves the right to change the terms, conditions and notices under which this Contest is offered.

By participating in this Contest, all entrants agree to be bound by these Terms and Conditions. The decisions of the Contest judges are final.
