**Location:** 612 Highway 4 North; Rosetown, SK.

**Pool Rental:**

The main pool of the Rosetown Leisure Aquatic Centre (RLAC) is available for rental by community groups; organizations and individuals during the summer season (June 1<sup>st</sup> to August 31<sup>st</sup>). Please note that these dates are a guideline as the actual pool opening and closing dates may vary each season. Use of the hot-tub would be included in the main pool rental as per rental guidelines below.

The pool rental rates (set in 2010) are as follows:

- Base rate: \$100.00/hour for the full pool for one lifeguard (based on 30 or less users)
- Additional users: For every additional 30 people you would increase the rental by \$25.00/hour.
- Minimum rental is one hour.

**Rental Guidelines:**

- (1) There will be no alcoholic beverages allowed in the facility.
- (2) The users of the facility must leave the facility in the same state of cleanliness that they found the facility in. If left in an unsatisfactory condition, the users will be charged a fee for clean-up.
- (3) The users of the facility will respect the RLAC staff that are on duty at the time of the rental.
- (4) The users will identify, through this agreement, a responsible and accountable representative of their respective group or organization who will be in attendance for the entire event to ensure that guidelines are adhered to.
- (5) Pool rentals are not allowed during Public Swimming times in the RLAC Pool Schedule.
- (6) Pool rental cancellations must be made 24 hours in advance of the booking otherwise the user group will be charged 50% of their rental. Cancellations must be made Monday to Friday during office hours between 9:00 am and 5:00 pm at the office of the Recreation Director; or after hours and on weekends at the RLAC at 306-882-2213.
- (7) The Parks & Recreation Department reserves the right to decline pool rental requests based on the next day's schedule at the facility; and to change this policy at any time.
